#### 8.2. Exposure controls:

Engineering controls:

Extraction is necessary to remove fumes evolved during reflow. Ensure adequate ventilation, especially in confined areas.

Respiratory protection:

In case of aerosol formation, we recommend wearing of appropriate respiratory protection equipment with ABEK P2 filter (EN 14387).

This recommendation should be matched to local conditions.

Ensure adequate ventilation.

An approved mask or respirator fitted with an organic vapour cartridge should be worn if the product is used in a poorly ventilated area
